EMS TRAINING TUITION REIMBURSEMENT**

**Purpose Statement:** The NAEMS Tuition Reimbursement Program is meant for the development of EMS training in rural or underserved areas and available to qualified students who show a need for tuition reimbursement.

**Applicants, applying for tuition reimbursement, must meet the following requirements:**

1. Be a member of an agency, who is a member of NAEMS.
2. Demonstrate a need as determined by the Steering Committee.
3. Reside within the catchment area of sponsoring agency and agree to remain within that area for two years after finishing the class and becoming AZ State Certified.
4. Have a letter of support from the sponsoring agency that states:
  - Applicant intends to remain in services area,
  - Sponsoring agency will obtain necessary equipment to support applicant,
  - Disclose all (if any) other financial assistance.
5. Applications must be filled out completely and forwarded to the NAEMS Secretary.

**Reimbursement fees currently are as follows:**

BLS training	\$ 500.00
BLS refresher	\$ 150.00
ALS training	\$ 1,000.00
ALS refresher	\$ 200.00

**Applicants may apply for tuition reimbursement AFTER successful completion of training program. (Include proof of course completion with application)**

**Approved reimbursements will NOT be paid to applicant until proof of successful AZ State certification.**

**Applications will be reviewed by the NAEMS Steering Committee. Their recommendation will be forwarded the NAEMS Board of Directors for approval. The Boards of Directors decision is final.**
